#### Vaccines for Children (子どもの予防接種)

There are two types of vaccinations for children: Government provided routine immunization (rotavirus, hib, pediatric pneumococcal, hepatitis B, DPT-IPV, BCG, MR, varicella, Japanese encephalitis, DT, and HPV (human papillomavirus)) and voluntary immunization. Check your Maternal and Child Health Handbook so that your child can receive the recommended immunizations at the appropriate time.

2 Preschoolers must be accompanied by guardians. One preschooler require one accompanying guardian. (Infants wearing diapers are prohibited from using the pools.)

# ♦ Test fee assistance for EIKEN test (test in practical English proficiency) begins. (英語検定受験料補助がはじまります。)



School Education Division

Toyoake City will subsidize test fees for primary, junior high, and high school students living in the city who take the test in practical English proficiency Test (EIKEN test) conducted by the Eiken Foundation of Japan.

#### **◆**Persons eligible for assistance

Those who fall under any of the following and are not delinquent in payment of city tax

- (1) Parents/guardians of children who live in the city and have taken the EIKEN test Grade 3 or above (Students in a national, private, or public elementary or junior high school)
- (2) Parents/guardians of children who live in the city and have taken the EIKEN test Grade 2 or above (Students in high school, upper secondary course of a secondary education school, high school course of a special support school, technical college (1st to 3rd year), or upper secondary course of a vocational school)

#### Amount of money to be provided

The full amount of the examination fee for one test determined by the Eiken Foundation of Japan for each child, student, and other EIKEN test taker. (Up to once a year)

\*You can apply regardless of whether you pass or fail. \*Group examination fees are not eligible for assistance.

◆ Period Available at any time (The final deadline is the last day of the fiscal year in which you took the EIKEN test.)

# **♦**Application for exemption of payment of national pension

**contributions** (国民年金保険料免除などの申請) Kasadera Pension Office *Tel:052-822-2512* 

Those have difficulty paying national pension contributions due to low income or other reasons can apply for exemption or postponement of payment of national pension contributions for fiscal year 2023 (July 2023 to June 2024). If you do not pay your national pension contributions without applying for an exemption, you may not be able to receive the Disability Basic Pension or the Survivors Basic Pension.



[Target people] Those who have difficulty paying national pension contributions due to low income in the previous year or for other reasons

**[Application]** Applications will start from 3 July (Monday).

**In addition** In principle, applications are required to be renewed every fiscal year.
