## The child allowance system will change from October 2024.

Child Rearing Support Division

If you fall under any of the following categories **1** to **3**, you will need to go through the necessary procedures (submit documents).

**①**People who are not receiving a child allowance or special benefits because they have an income above the **upper income limit 2**People raising children of high school age (born between April 2, 2006 and April 1, 2009) (Excludes those currently receiving a child allowance or special benefits) **3 Those who are receiving a child** allowance or special benefits and have a college-age child (born between April 2, 2002 and April 1, 2006) and are raising three or more children, including children up to high school age

If the eligible child is registered as a resident in Toyoake City, the application form and other documents will be sent to the child's head of household. If the eligible child lives outside Toyoake City and meets the above categories 1 to 3, download the application form from the Toyoake City website and apply. If the applicant resides outside Toyoake City, he/she should apply to the municipality where he/she is registered as a resident. If you are a civil servant, please apply to your employer.

★ If you fall under the following categories, you do not need to apply; we will pay you the revised allowance amount in December. ★

OPeople who are currently receiving child allowances and whose allowance amount will remain the same after the revision→No notification will be given after the system revision. ○People who are currently receiving special benefits→We will send you a notification of payment category change by the end of October. OPeople who are currently receiving child allowances and who have previously received child allowances or special benefits from Toyoake City for their high school-aged child(ren).→We will send you a notification of the amount revision by the end of October.

### **Vaccines for Children** (子どもの予防接種)

There are two types of vaccinations for children: Government provided routine immunization (rotavirus, hib, pediatric pneumococcal, hepatitis B, DPT-IPV, DPT-IPV-Hib, BCG, MR, varicella, Japanese encephalitis, DT, and HPV (human papillomavirus)) and voluntary immunization. Check your Maternal and Child Health Handbook so that your child can receive the recommended immunizations at the appropriate time.



### **Nursery school application procedure**

(令和7年度 保育所等申込手続きについて) **Simultaneous Applications** 

Childcare Division

### [Entrance criteria for nursery schools]

Children cannot be looked after at home owing to any of the following conditions

- (1) Working (60 hours or more a month)
- (2) Mother's pregnancy and childbirth (Eight weeks before and about 8 weeks after delivery)
- (3) In case of illness or disability
- (4) Those who are caring for relatives constantly
- (5) Recovering from a disaster such as earthquake, storm and flood, or fire
- (6) Those who are looking for a job continuously (60 hours or more a month)
- (7) Parents/guardians are students or enrolled in a job training program. (60 hours or more a month)
- (8) Parents/guardians are taking childcare leave. (Only when the child is three years of age or older)
- (9) Any other case in which it is accepted that there is a clear need for childcare.

### [Application documents]

Starting Tuesday, October 1, a URL for an explanatory video and application forms for mass admission applications will be posted on the Toyoake City website.

Application forms will also be distributed at the Childcare Division and seven public nursery schools (only between Tuesday, October 1 and Tuesday, October 8).

### ◆Health Check for Children Due to Enter Elementary School

Next Spring (来春小学校に入学されるお子さんの健康診断―就学時健康診断―)

School Education Division



In Japan, children born between April 2, 2018 and April 1, 2019 will enter elementary school in April 2025. Children with foreign nationality who are resident in Toyoake City and who were born during this period may also enter the city's public elementary schools in April 2025. The city will hold health checks for children before they begin school. If you do not receive a notice by September 17, please contact the School Education Division at the City Hall.

### ♦Subsidy for influenza vaccine fees for 3rd year junior high school

**students**(中学3年生インフルエンザワクチンの費用助成)

Child Rearing Support Division

**Target people** Third-year junior high school students or those of equivalent age who are registered as a resident of Toyoake City as of the day of vaccination (Born between April 2, 2009 and April 1, 2010)

**[Subsidy period]** Tuesday, October 1 – Friday, January 31,2025

[Application] Make an appointment to get vaccinated at a medical institution in Toyoake City that offers vaccination directly and get vaccinated. \*Please contact the eligible medical institution for application procedures and application periods.

[Cost] Pay the amount after subtracting the subsidy (2,000 yen) from the vaccination cost to the medical institution as an out-of-pocket expense.

【Items to Bring】 Identification (e.g. My Number health insurance card)

X Vaccinations performed outside the subsidy period or at a medical institution outside Toyoake City are not covered by the subsidy. Influenza vaccination is voluntary, so please receive it with proper understanding.

### ♦ Subsidy for routine and optional COVID-19 vaccinations

(新型コロナ定期予防接種と任意予防接種の費用助成) Health Promotion Division

Special temporary vaccinations for COVID-19 vaccines until fiscal year 2023 (vaccinations fully funded by public funds for all ages) ended on March 31, 2024. From fiscal year 2024, COVID-19 is classified as a Class B disease under the Immunization Act, and like influenza, the vaccination will be administered as a "routine vaccination" primarily for those aged 65 and over. In addition, Toyoake City will provide subsidies to some eligible individuals for "voluntary vaccinations" that are not covered by "routine vaccinations."

**[Subsidy period]** Tuesday, October 1 – Friday, January 31,2025 (Planned)

**[Application]** Apply directly to the eligible medical institution from Wednesday, September 25 to Friday, January 24, 2025. **[Place]** Apply directly to the eligible medical institution

- \*The implementation period and application period may vary depending on the medical institution.
- \*\* People who wish to receive the vaccination at a medical institution outside Toyoake City may need to complete procedures in advance.

#### Health Damage Relief System

In general, vaccination may cause health injury (illness or disability) due to an adverse reaction, in addition to temporary side effects such as fever, swelling or pain.

A relief program has been established because, although extremely rare, it cannot be eliminated entirely.
