Toyoake City will provide subsidies as congratulatory gifts to families of new first graders in order to enhance childcare support.



- 1. Target people Parents of a new first grader in FY2025 who have Toyoake City resident certificates as of the day of their child's elementary school entrance ceremony and the day of their application for the subsidy
- 2. Amount of the subsidy Up to 50,000 yen per child
- **3. Scope of the subsidy** Expenses for goods and services necessary for supporting new first graders Expenses supported by receipts dated from Wednesday, January 1, 2025 to Friday, December 26, 2025 are eligible for the subsidy. Keep the receipts or other documents since they are required for the application.
- 4. Period 01/April 2025(Tuesday) 26/December 2025 (Friday) A postmark is effective on the day
 - Detailed procedures for the application will be sent together with the school attendance notice by mail to households eligible for the subsidy In January 2025.

Vaccines for Children (子どもの予防接種)

There are two types of vaccinations for children: Government provided routine immunization (rotavirus, hib, pediatric pneumococcal, hepatitis B, DPT-IPV, DPT-IPV-Hib, BCG, MR, varicella, Japanese encephalitis, DT, and HPV (human papillomavirus)) and voluntary immunization. Check your Maternal and Child Health Handbook so that your child can receive the recommended immunizations at the appropriate time.

▶Notification of final tax declarations (確定申告のご案内)



Inquiries Taxation Division

If you use "e-TAX" (the online national tax return filing and tax payment system) set up

by the National Tax Agency (NTA), all you have to do is just input some data, such as amounts of money, in accordance with the instructions on the display, which will have the system draw up your tax return forms and related statements based automatic calculations.

Furthermore, if you use your "My Number Card" (the individual number card), which is linked with "Mynaportal" (the online portal for administrative procedures), your tax deduction certificates and other data will be automatically entered into the system. You can file your tax return through e-Tax (the online tax return filing system) on your smartphone or computer at home without the need for presenting yourself at a tax return filing venue. Please refer to e-TAX on the website of the NTA for details.

XYou can also print out your tax return form and submit it to the tax office by mail or any other means.

In addition: A prior appointment is required. **Please note that after Monday, March 3, the Taxation Division will not be able to provide consultations on final tax return filing or help you prepare the documents.

[WINC Aichi Venue] Monday, February 17 - Monday, March 17

(excluding Saturdays, Sundays, and public holidays/Open...Sunday, March 02)

An admission ticket is required for entering Winc Aichi.On the day of the event, admission tickets will be distributed at the venue, but they can also be purchased online (LINE app) in advance.

Depending on the distribution situation, you might be asked to come on a different day.

Final tax return filing at Atsuta Tax Office from January

- From Monday, January 6 to Friday, January 31, consultations on final tax return filing will be provided by advance appointment only (by phone). If you come to the tax office without an appointment, we cannot provide a consultation on the filing.
- From Monday, February 3 to Friday, February 14, consultations on the filing will be provided by handing out numbered tickets. From Monday, February 17 to Monday, March 17, the Atsuta Tax Office will not set up a venue to file final tax returns.

Filing of final tax returns at the City Hall is by advance appointment only. Time to file final tax returns for 2024

Without an appointment, even if you come to the venue, you will not be admitted. So, please be sure to make an appointment in advance. (A prior appointment is required.)

Period to declare Monday, February 17 -Friday, February 28

How to make an appointment

- Appointments by postcard
- Please fill in the necessary information on the postcard and send it by mail by January 17 (Fri)

(Postmarked on or before that date).

If there are many appointments, a lot drawing will be conducted. Online appointments Starts at 9 a.m., Wednesday, January 15 via the appointment system

(Applications will be closed when the maximum capacity is reached.)

Please put a circle in the space under the date of your request. Free tax accountant consultation services at not available on Thursday, February 27 and Friday, February 28.



- The appointment needs to be made by postcard or online only.
- The appointment cannot be made at the venue windows or by phone.
- There will not be a waiting list.

 •Do not use a pencil nor an erasable ink ballpoint pen to fill out the postcard.
- To write the necessary information on a postcard, you can download a form from the city's website to attach it to the postcard or you can obtain it at the Taxation Divisio A handwritten postcard without the form attached is acceptable as long as it include the necessary information
- Please be aware that the fewer the desired dates requested, the less likely that any of

them will be selected in the drawing.

•You cannot specify your appointment time when making an appointment by postcard.

(National health insurance tax, medical insurance premium for senior citizens, and nursing care insurance premium) (納付済額のお知らせ -国民健康保険税・後期高齢者医療保険料・介護保険料-)



Toyoake City issues "Notification of payment amount" postcards stating the amount of social insurance fees (National health insurance tax, medical insurance premium for senior citizens, and nursing care insurance premium) paid to the city during Reiwa 6 (2024). This notification can be used for social insurance fee deductions that you can receive when filing income taxes and municipal/prefectural tax returns.

We will send out this notification of payment amount at the end of January to coincide with tax return season.

COVID-19 vaccine (新型コロナワクチン)

Date Until Monday, March 31, 2025 (The period has been extended.)



(Routine Immunization) Target people Those who are registered residents of Toyoake City on the day of the vaccination, "aged 65 and above" or "aged between 60 and 64 with a disability equivalent to a grade 1 physical disability due to heart, kidney, respiratory, or other diseases"


[Cost] Copayment: ¥2,000 (Those on welfare are exempted from paying a copayment.)

(Voluntary vaccination) [Target people] Those who are registered residents of Toyoake City on the day of the vaccination, "aged 14 or 15 (Grade 9)" or "with underlying medical conditions that put them at high risk for severe COVID-19 illnesses but not eligible for routine vaccinations"

[Cost] Copayment: ¥5,000

(Changes from the last fiscal year) ● The vaccination ticket will not be sent to you. Please apply for your vaccination. ● The city will not conduct mass vaccination or have an appointment system in place.
