### ◆Congratulatory Gifts of Money to Be Provided for New First Graders (新入学祝金を交付します)

School Education Division



*Toyoake City will provide subsidies as congratulatory gifts to families of new first graders in order to enhance childcare support.*

- 1. Target people** Parents of a new first grader in FY2026 who have Toyoake City resident certificates as of the day of their child's elementary school entrance ceremony and the day of their application for the subsidy
- 2. Amount of the subsidy** Up to 50,000 yen per child
- 3. Scope of the subsidy** Expenses for goods and services necessary for supporting new first graders
- 4. Period** 01/April 2026(Wednesday) — 28/December 2026 (Monday) *A postmark is effective on the day*

●Detailed procedures for the application will be sent together with the school attendance notice by mail to households eligible for the subsidy In January 2026. ●

### Routine vaccinations for children (子どもの定期予防接種)



Routine vaccines include the 5-in-1 vaccine, BCG vaccine, MR vaccine, 2-in-1 vaccine, and those for rotavirus, Haemophilus influenzae type b (Hib), pneumococcal infection in children, hepatitis B, chickenpox, Japanese encephalitis, and human papillomavirus (HPV).

Have your child vaccinated at a medical institution at the appropriate time for each vaccination.

## ◆ Notification of final tax declarations (確定申告のご案内)



Inquiries Taxation Division

● If you use “e-TAX” (the online national tax return filing and tax payment system) set up by the National Tax Agency (NTA), all you have to do is just input some data, such as amounts of money, in accordance with the instructions on the display, which will have the system draw up your tax return forms and related statements based automatic calculations.



e-TAX on the website of the NTA

● Furthermore, if you use your “My Number Card” (the individual number card), which is linked with “Mynaportal” (the online portal for administrative procedures), your tax deduction certificates and other data will be automatically entered into the system. You can file your tax return through e-Tax (the online tax return filing system) on your smartphone or computer at home without the need for presenting yourself at a tax return filing venue. Please refer to e-TAX on the website of the NTA for details.

※ You can also print out your tax return form and submit it to the tax office by mail or any other means.

## Please be aware of the expiration date of the electronic certificate on your My Number Card.

After the expiration date, you will no longer be able to file your tax return using e-Tax.

Those whose expiration date is less than three months away will be sent an expiration date notice, so please come to the Resident's Division when you receive it.

## ◆Notification of payment amount

(National health insurance tax, medical insurance premium for senior citizens, and nursing care insurance premium)

A postcard listing the social insurance premiums (national health insurance tax, medical care insurance premiums for elderly in the latter stage of life, and long-term care insurance premiums) paid to the city during 2025 will be sent to you **in late January**.

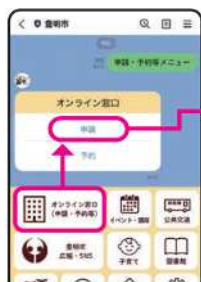
