◆Child-rearing support allowance responding to rising prices

（物価高対応子育て応援手当）



Child Rearing Support Division

You can receive a one-time payment of 20,000 yen per eligible child.

You do not need to apply in principle. Those who received the child allowance payment for September 2025 from the city will have the support allowance deposited into the same bank account in February.

Those who need to apply will receive instructions from the city or their workplace.

Routine vaccinations for children (子どもの定期予防接種)

Routine vaccines include the 5-in-1 vaccine, BCG vaccine, MR vaccine, 2-in-1 vaccine, and those for rotavirus, pneumococcal infection in children, hepatitis B, chickenpox, Japanese encephalitis, and human papillomavirus (HPV). Have your child vaccinated at a medical institution at the appropriate time for each vaccination.

◆Time to Submit Final Tax Returns

(確定申告が始まります)



Taxation Division, Toyoake City Hall

The filing period for the final tax return begins Monday, February 16 and ends Monday, March 16, 2026.



e-Tax makes final tax return filing more convenient!



Tax return preparation corner -Available online from a PC or smartphone-

Simply follow the instructions on the screen to enter amounts and other details, and you can prepare tax returns for income tax, consumption tax, and gift tax returns, a financial statement for blue return, and a statement for earnings and expenses, and submit them via the e-Tax system.

- ① Submit via e-Tax
- ② Send by mail or correspondence delivery to the Atsuta Branch of the Nagoya Regional Taxation Bureau Submission Processing Center (7-17 Hanaomote-cho, Atsuta-ku, Nagoya City 456-8570)
- ③ Bring to the Toyoake City venue (hall at the city hall)

◆National pension deduction certificates used for final tax return

In order to deduct the national pension premium from your income as a social security deduction, you need a certificate of the national pension premium paid during 2025.



●Certificates● Either of the following ① or ② documents

- ① Receipt for insurance premium
- ② Social insurance premium deduction certificate or national pension insurance premium deduction certificate

◆To elderly who feel insecure at home because they live alone (or for other reasons), Use a monitoring and emergency report system, commonly known as Mimamoru-kun.

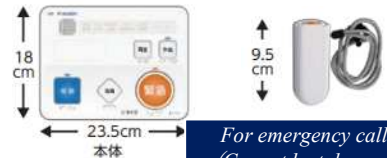
- Citizens aged 65 and older who live alone
- Households with elderly only
- Households that are occupied only by elderly from (roughly) 9 a.m. to 6 p.m.



Service provider: ALSOK Co., Ltd.

Cost: 700 yen/month (Direct debit made by ALSOK)

Items needed for installation of the system: Bankbook, bank registration seal, house key (only for those who wish to leave a key for the service)



For emergency calls

【What does “Mimamoru-kun” do?】



The city website

- 1 Its sensors sense the opening/closing of your toilet room door(s), monitoring your daily wellbeing
- 2 It lets you contact the Monitoring Center in an emergency by just pressing a button.
- 3 The Monitoring Center calls you once a month to check your health condition, wellbeing, etc.
- 4 It allows you to obtain health counseling 24/7, 365 days a year at the push of a button.
- 5 Advice on how to prevent heatstroke and disaster alert info will be conveyed via audio message.

◆Voluntary vaccination subsidy program

(任意予防接種助成事業)



Health Promotion Division

Vaccinations that are not included in the regular vaccinations are generally optional and must be paid for in full by the individual; however, the city provides subsidies for some vaccines.

【If you are getting vaccinated at a designated medical institution in the city】


You only have to pay the fee minus the subsidy amount (no procedures required).

【If you are getting vaccinated at a medical institution outside the city】

If you pay the full cost yourself and apply for a subsidy by notifying the type of vaccines with proof of vaccination and a receipt within six months of inoculation, the subsidy amount will be paid to you by bank transfer.
